In our February 4, 2011 letter, we directed you to remove certain statements posted on one of your Group's websites<sup>1</sup> at [www.sokco.info](http://www.sokco.info) that you should have been aware were false and misleading. To date, those misstatements remain on your site.

You recently compounded the problem by sending out letters, dated February 14, 2011, to possibly thousands of Vacation Club members and directing them to your website. Many of those members were previously unaware of your published misstatements. By exposing those members to your statements, you have further opened yourselves to claims by the Vacation Club and its Board of Directors.

We again demand that you remove all of the previously identified untruthful statements from your website. The damage you are causing with these false statements about members of the Board is irreversible. You must stop posting these statements on your website immediately. By noon tomorrow, February 24, 2011, please email me at [doyasato@hawaiicondolaw.com](mailto:doyasato@hawaiicondolaw.com) to confirm that you have removed the offending statements. Failure to do so will result in additional claims by the Board and the Vacation Club as a whole.
